- [ix] Training on special topics supported by donating outdated machinery, equipment, cut- sections, charts etc.

### **Loknete Gopinathji Munde Institute of Engineering Education And Research, Nashik shall provide**

- [i] Internship. Training, Lab Visit permissions in such areas as may be mutually agreed between the parties, more particularly described in this agreement.
- [ii] Experts for conduct of training at LoGMIEER Campus and /or at the Industry Premises.
- [iii] Certificates Completion Letter to all the students who have successfully completed the Internship/ Training / Projects conducted at Industry premises or at LoGMIEER.

### **[3] MUTUAL OBLIGATIONS:**

- [i] Both the parties shall appoint one person as one point of contact smooth execution of MOU.
- [ii] This collaboration shall not be exclusive to both the parties and shall not for the disallow each party from having similar collaboration with others. Except as Stated in this MoU, there shall be no obligation on any party to compensate the other in any manner or to make any claim.

[iii] Each Party shall respect the other's Intellectual Property.

[iv] Nothing contained in this MOU shall be constructed as resulting in the creation of a relationship of both The Principal of LoGMIEER and Management of Advent Engineers. LOGMIEER and Advent Engineers are not authorized to make any representation, contractor commitment on behalf of the Industry/LOGMIEER without the prior written consent of the other party.

#### [4] WARRANTIES:

[i] Each Party shall ensure that the other party is not to put to any liability for any act of respective party under this MoU.

[ii] Each Party represents that they have full power and authority to enter in this MoU in general.

#### [5] COMMERCIALS:

[i] LOGMIEER and Advent Engineers will design programs on mutual understanding and decide fees if any to be charged for the students.

[ii] The training, Lab Visit will be conducted at the LoGMIEER or Industry facility at a time bound manner as per the availability and schedule of both the parties.

#### [6] GENERAL:

[i] Both the parties may receive information proprietary to other party "The Confidential Information" in the course of performance of their obligations under this MoU. Confidential information is not to meant to include any information which is

[a] Publically available

[b] Rightfully received by the parties from the third parties without accompanying secrecy obligations

[c] Already in the party's possession and was lawfully received from sources other than the parties.

[d] Independently developed by the parties.

[ii] The two bodies understand and acknowledge that the confidential information is valuable and confidential and agrees that it will all the times be kept entrust, to be disclosed to only such persons as have a "need to know" the same for effective

implementation of this MoU and that it will only be used by the parties for the benefit of the others.

[iii] Both the parties understand and agrees that all written or all tangible area and documentation developed and procured by the other party in performing its obligations under this MoU, whether in printed or in electronic for, belongs to the other party.

[iv] Both the parties shall not use the name and brand of the other party in any advertisement or make any public announcement without the prior written approval of the other.

[v] Each party shall be at the liberty to terminate this MOU with a written notice period of one month to the other party without any compensation.

[vi] Any and all the disputes or differences between LoGMIEER and Advent Engineers arising out of or in the connection with this MoU or its performance shall, so far as it is possible, be settled by negotiations between the parties amicably through consultation and understanding.

#### **[7] INDEMNIFICATION:**

[i] Both the parties shall indemnify and hold each other harmless from and against any claim, loss, liability, or expenses, including, but not limited to damages, patent and Trademark Infringement, costs.

[i] **Duration:** This MoU shall be valid for 3 years from the date of signing and shall automatically be renewed for successive period of 2 more years, unless either Party notifies in writing to the other Party of its intention to terminate this MoU ninety days in advance.

[ii] **Purpose:** This MoU is for the collaboration between the parties for mutual benefit. This Memorandum is not a legally binding contract and under no circumstances does this Memorandum subject either of the parties to liability for breach, whether material or minor, of contract or any other liability under national and international law or any other applicable law.

[iii] The Parties may nominate an identified individual to establish a "Joint Working Group" to manage and execute the corporate activities mentioned in this MoU.

[iv] Parties may use other party's logo/branding only after prior permission from each other.
